

TITLE 11 - FIREWORKS

Chapter 11.1 General Provisions

11.1.010 Authority and Declaration of Purpose. This Code is enacted in order to provide for the safe and orderly use of fireworks within the Shoalwater Bay Indian Reservation- To regulate the sale of fireworks for the health and safety of Tribal Members and others living on the Shoalwater Bay Indian Reservation and protection of Tribal Resources. All previous Fireworks Ordinances are hereby revoked by the passage of this amended Code. This ordinance is subject to change at any time by Tribal Council.

- **It is a privilege to sell fireworks not a RIGHT**

11.1.020 Definitions.

- "Fireworks" shall mean any device containing any combustible or explosive substance (not to exceed 1.4 grams, class C) for the purpose of producing a visible or audible display of combustion, explosion, deflagration, or detonation, but not including any firearms.
- "Fireworks Stand" shall mean an establishment at which fireworks are offered for retail sale.
- "License" shall mean the authorization issued by the Shoalwater Bay Tribe under this Code to engage in the transport, possession, discharge, or sale of fireworks within reservation boundaries.
- "Licensee" shall mean the person to whom a license has been issued under this Code.
- "Tribal Court" shall mean the Shoalwater Bay Tribal Court having jurisdiction on the Shoalwater Bay Indian Reservation.
- "Crimes against Persons" shall mean any crimes against persons, and

- found guilty in any criminal jurisdiction.
- g) "Employee of Licensee" shall mean an authorized employee of the licensee the age of 16 and over.
 - h) "Wholesaler" shall mean any person licensed to sell fireworks to licensed firework retailers.
 - I) "Wholesaler License" is for specific sale of wholesale fireworks to licensed firework retailers only.
 - J) "Safe Storage" shall mean a heavy gage metal container a minimum of 50 feet away from housing.

11.1.030 General Prohibition. It shall be unlawful for any person to transport, possess, discharge, sell, or offer for sale any fireworks within any area under the jurisdiction of the Shoalwater Bay Indian Tribe except as provided in this Code.

Chapter 11.2 Licensing

11.2.010 Fireworks License Required. The sale, offers for sale, transport, or transfer of fireworks shall be unlawful when done by any person unless the person has a valid Tribal Fireworks License, or is an approved employee of the licensee.

- A) **Seasonal or One-Year License**- required to sell retail fireworks.
- B) **Satellite Wholesale License**- required for satellite wholesalers to sell fireworks to licensed stand owners.
- C) **Mobile Wholesale License**- required for mobile wholesalers to sell to licensed firework stands.
- D) **Display Permit**- is required for any person/business advertising a public display using class B or larger.

11.2.020 Eligibility For License. No license shall be issued to any person unless he/she is an enrolled member of the Shoalwater Bay Indian Tribe and is at least twenty-one (21) years of age. Each member may only obtain one retail license.

11.2.030 License Application. Any person wishing to receive a Tribal Fireworks License shall apply to the Shoalwater Bay Tribal Council. The application **shall** provide the following information:

- 1) Name
- 2) Address
- 3) Telephone Number
- 4) Name and Location where fireworks will be sold
- 5) Length of fireworks stand
- 6) Criminal Background Check with fee payment.

11.2.040 Application Fee. Every applicant for Fireworks Sales License must submit with his/her application, the cost of the Criminal Background check for licensee before receiving a license, and the fee associated with their license; Wholesaler Licenses are required to provide safe storage for bulk fireworks.

A) Seasonal License Fee -\$300.00 (which includes a non-refundable \$50.00 clean up fee) license valid from one week prior to Memorial Day to Labor Day weekend.

B) One-Year License Fee- \$500.00 (which includes a non-refundable \$50.00 clean up fee).

C) Satellite Wholesale License -\$500 for a satellite wholesale license

D) Mobile Wholesale License - \$250.00 for a mobile wholesale license.

E) Display Permit - \$250.00 for a display permit.

11.2.050 License Approval Process – Notice of Denial. Licenses shall be issued by the Tribal Council on a case by case basis. Any person whose application is denied shall be notified in writing of such action with a statement of the reasons for the denial.

11.2.055 Ineligibility For License. No license shall be issued to any person unless he/she receives positive results on the Criminal Background check with regards to crimes against persons and property within the past ten years.

11.2.060 Licensee and Employees of Licensee. No youth under the age of sixteen (16) shall be allowed in the stand unless the licensee or authorized employee of licensee is present in the stand. The licensee is responsible for all violations of this Code committed by his/her employees and/or others, while engaged in activities related to the sale or discharge of fireworks.

11.2.070 Duration of License. Four types of fireworks licenses are available.

- A) **Seasonal License** shall be effective from the weekend before Memorial Day to Labor Day weekend. **The Fireworks stand; and all signage must be removed BEFORE the expiration date of this Seasonal License.** Failure to do so may result in denial of future license.
- B) **One-Year License** shall be effective for a period of one year from the date of issuance.
- C) **Satellite Wholesale License** shall be effective for a period of one year from the date of issuance.
- D) **Mobile Wholesale License** shall be effective from the weekend before Memorial Day to Labor Day weekend.

11.2.080 Rocket City. All yearly licensed fireworks stands in Rocket City must be placed fifty (50) feet from center line to allow for the use of this multipurpose lot during the rest of the year.

11.2.090 Suspension of License for Failure to Comply with Code. Failure of the licensee to abide by the requirements of this Code will constitute grounds for suspension of the licensee’s Tribal Fireworks License until the licensee is back in compliance, as well as enforcement of the remedies provided below.

CHAPTER 11.3 PROHIBITED FIREWORKS

11.3.010 Prohibited Fireworks. It shall be unlawful for any person to sell or ignite fireworks within the jurisdiction of the Shoalwater Bay Tribe unless the fireworks comply with Federal fireworks regulations. The regulations of the **UNITED STATES CONSUMER PRODUCT SAFETY COMMISSION, 16 C.F.R. 1500, ET SEQ.**, and as they may be amended, are hereby incorporated by reference as part of this Code.

- A) **No Fireworks Zone.** It shall be unlawful for any person to ignite any fireworks within the posted “NO FIREWORKS ZONE”. Please refer to updated Fireworks Zone Map, attached to license.

CHAPTER 11.4 SAFETY REQUIREMENTS FOR FIREWORKS STANDS AND WHOLESALERS

11.4.010 Retail Sales From Motor Vehicles Prohibited. No person shall sell retail fireworks from any motor vehicle or any other location other than that stated on valid Fireworks License. Wholesalers are required to store fireworks in a metal container.

11.4.020 Fire Extinguisher Required. All fireworks outlets shall have at least one appropriate fire extinguisher readily accessible in the stand. At least two

fire extinguishers are required in stands of twenty (20) feet long. The fire extinguisher(s) shall have at least ten pounds (10 lbs.) of dry chemical or the equivalent. It is the responsibility of licensee to maintain properly working fire extinguishers.

11.4.030 Smoking Prohibited. Smoking shall not be permitted in a stand or within fifty (50) feet of the stand. Signs shall be posted at each outlet advising the public that smoking is not permitted in the area.

11.4.040 Discharge of Fireworks Restricted. No person shall discharge fireworks within fifty (50) feet of a stand. Signs shall be posted at each outlet advising the public that the discharge of fireworks is not permitted in the area.

CHAPTER 11.5 ENFORCEMENT

11.5.010 Penalties. A violation of any section of this Code shall be a civil infraction, under the jurisdiction the Shoalwater Bay Indian Tribe. Any person who commits a civil infraction of this Code shall be assessed a fine of \$150.00 per violation. In addition to the fine, the Court may impose restitution for actual damages. **Any person who sells fireworks without first obtaining a license is subject to a mandatory \$1,000.00 fine. Additionally, all operating stands are subject to full inspection by Tribal Law Enforcement.**

11.5.020 Additional Relief. The Tribal Court may, in addition to other remedies in this Code, grant to the Tribe such other relief as is necessary and proper for the enforcement of this Code, including—but not limited to—suspension or revocation of the license and injunctive relief for acts in violation of this Code.

11.5.030 Contraband – Seizure, Forfeiture. All fireworks within the jurisdiction of the Shoalwater Bay Tribe held, owned, or possessed by any person in violation of this Code are hereby declared to be contraband, and subject to forfeiture to the Tribe. In addition to the right of Tribal Law Enforcement to immediate seizure of contraband, upon application of the Tribal Law Enforcement, the Tribal Judge shall issue an Order directing Tribal Law Enforcement to seize contraband fireworks. A copy of the Court Order shall be delivered to the person from whom the property was seized or shall be posted at the place where the property was seized. See Section 11.3.010.

11.5.040 Forfeiture Hearing. Within two weeks following the seizure of contraband under Section 11.5.030, a hearing shall be held in Tribal Court at which time the operator or owner of the contraband shall be given an opportunity to present evidence in defense of his/her activities.

11.5.050 Notice of Forfeiture Hearing. Adequate notice of the hearing shall be given to the person from whom the property was seized, if known. If the person is unknown, notice of the hearing shall be posted at the place where the contraband was seized and at some other public place. The notice shall describe the property seized, and the time, place, and cause of seizure and given the name and place of residence, if known, of the person that the property was seized.

11.5.060 Disposition of Forfeited Property. If the Court declares the fireworks to be forfeited, all fireworks which are otherwise legal under this Code shall be auctioned, with proceeds paid to the Shoalwater Bay Tribe. Fireworks which are otherwise illegal shall be safely disposed of.

11.5.070 Seizure – May Be in Addition to Other Remedies. The seizure of contraband under Section 11.5.030 may be in addition to or separate from any other remedy in this Code available to the Tribe for violations of this Code.

CHAPTER 11.6 SEVERABILITY, SOVEREIGN IMMUNITY, CAPTIONS

11.6.010 Severability. If any provision of this Code or its application to any person or circumstance is held invalid, the remainder of this Code, or the application of the provision to other persons or circumstances is not affected.


11.6.020 Sovereign Immunity Preserved. Nothing in this Code is intended or shall be construed as a waiver of the sovereign immunity of the Tribe. No manager, officer, or employee of the Tribe shall be authorized, nor shall they attempt to waive the immunity of the Tribe.

11.6.030 Captions. Chapter, section, and subsection captions are for organizational purposes only and shall not be construed as part of this Code.







WHEREAS, the Shoalwater Bay Tribal Council is empowered to take all actions necessary for the exercise of powers delegated or vested in the Tribal Council pursuant to the Constitution of the Shoalwater Bay Indian Tribe; and,


WHEREAS, the Shoalwater Bay Tribe held a public hearing April 25, 2012 for comment; now
